# 2018 年企業社會責任領航計畫-冬季行動 2018 CSR Captain Program-Winter Action 活動報名簡章 Event Registration Guidelines

# 壹、 活動目的

# I. Event Objective

為使本國籍及外國籍學生深入瞭解臺灣企業文化,促進產學界良好交流,增進多元文化 以培養國際思維,於校園與社會扎根企業社會責任概念,由中鼎教育基金會(CTCIEF)及 台灣企業永續研訓中心(CCS)多次共同籌辦的第三屆「企業社會責任領航計畫」活動獲 得熱烈迴響,而本次「2018 年企業社會責任領航計畫-冬季行動 2018 CSR Captain Program-Winter Action」活動,由在國內就讀大專院校的本國及外籍學研生組隊,深 入觀察臺灣與國外企業發展及落實執行企業社會責任,藉由各隊不同國籍的學研生在活 動期間彼此相互學習、溝通及討論,邀請CSR相關領域的專家學者及企業代表進行課程 講授以及企業CSR經驗實務分享,並讓專家學者協同親自指導學員們提案報告書撰寫, 期學子能將在活動中的體驗與收穫帶回校園,並藉由社群媒體分享到自己的國家,將臺 灣企業CSR個案執行成果,傳播分享至全世界。同時學員們的創意提案,亦可以讓參與 經驗分享企業代表與指導專家學者獲得極具啟發性之回饋。

To afford domestic Taiwan and international students to gain a better appreciation of Taiwan's corporate culture, enhance the between and, stimulate multiculturalism and develop broad international perspectives, the CTCI Education Foundation (CTCIEF) and Center for Corporate Sustainability (CCS) have jointly planned the 3rd "CSR Captain Program", which is resounding. "2018 CSR Captain Program-Winter Action", to encourage domestic and international undergraduate and graduate students in Taiwan universities to observe in depth and consider the status quo of Taiwan's corporate development and implementation and realization of corporate social responsibility. Through the interchange among graduate and undergraduate students of diverse nationalities, and CSR case studies sharing and discussion with one another, They can learn from the invited related-field professors and the CSR sharing from the corporates. Additionally, the renowned experts help guide the attending students for making the proposal about CSR Captain Report. 4. **Submission of Reports for Review:** the 12 finalist teams, shall before noon, Tuesday, November 13, 2018, submit the "2018 Corporate Social Responsibility Captain Program-Winter Action Caption Report", for written review by the Judges.

5. **Submission of presentations:** prior to 21:00, Sunday, November 18, 2018, the presentations and international Communication Index Registration Form shall be submitted for use in the Participation Results activity.

六、成果發表會暨頒獎典禮:107年12月1日(星期六)各隊伍進行口頭成果發表會暨 頒獎典禮,提供「中鼎 CSR 獎學金」第一名新台幣2萬元整、第二名新台幣1 萬6千元整及第三名新台幣1萬2千元整,其餘隊伍經評審委員核可有獲獎資格者 皆頒發獎學金新台幣1萬元整。

6. **Results Presentation and Awards Ceremony:** on Saturday, December 1, 2018, each team will provide an oral presentation at the Participation Results and Awards Ceremony, with the First Prize winner of the "CTCI CSR Scholarship" receiving NT\$20,000, Second Prize receiving NT\$16,000, and Third Prize receiving NT\$12,000, with the remaining teams selected by the Judges with qualification for recognition each receiving NT\$10,000 scholarships.

一、報名資格:

1. Registration Qualifications:

Undergraduate or graduate students in domestic universities from Taiwan or international students. As for international students, the following are so deemed:

Exchange students (exchange program international students, mainland China including Hong Kong and Macao exchange students)

3. 華語生(語言中心學生)

Chinese language students (language center students)

4.陸生及僑華生(學位生)

Mainland Chinese and overseas Chinese students (degree candidate students) 註:為保障參與學生權益,參與過前二屆(2017&2018 春季行動)「企業社會責任領航計畫 CSR Captain

Program」之學生,不得再次參與本活動。

Note: So as to protect and ensure the rights of participating students, those who participated in the "2017 CSR Captain Program & 2018 CSR Captain Program-Spring Action" may not again participate in the event.

二、人數:請以學校具名、自訂隊名(4 位學生須為同一校),每隊限制為 4 人;報名者

**須含至少2國籍以上**(如台灣2位、馬來西亞2位等)。而每人僅可報名一隊,不可 重複報名,如有偽造或與事實不符之情事,主辦單位得取消該隊參與活動資格。 2. Number of Team Participants: Please list the university name, the self-styled team name (**the 4 students must belong to the same university**), and each team is limited to 4 members; Participants must include at least 2 nationalities (such as 2 Taiwanese, with 2 Malaysians, etc.). Each participant may register with only one team, and no repeat registrations are allowed, also, of there are any false or untrue matters, the event organizers may cancel the team's registration and participation qualification.

3. Besides completing the basic biodata for the 4 team members, and uploading scanned copies of one's [personal ID](passport or Permit to Enter Taiwan), and one's [student ID] or [certification of enrollment], there shall also be submitted (each in 250 Chinese or English characters or less):

4. The team captain shall collect (recommend designating a domestic student for this position), upload and complete all team members' aforementioned registration materials and submit same; then after review by the event organizers, await notice of confirmation of registration. (registration process flowchart as follows)

#### **VII. Explanation of Selection of Registered Teams**

- 一、篩選階段:主辦單位進行書面資料審核作業,其對 CSR 之認知、參與動機及組隊多 元性等項目審閱,篩選符合活動資格之隊伍,選取 12 隊晉級評選階段。若入選之前 12 隊中之任一隊無法於研習工作坊及成果評選當天全員或全程參與活動時,主辦 單位有權於活動前以備選隊伍依序遞補。
- 1. Initial Selection: The organizers will undertake review processes for the written submissions, including CSR knowledge, motivation for participation, and diversity of the team, etcetera, to select teams qualified for the event, of which 12 teams will be determined finalists. If any team selected among the 12 finalists, is unable to ensure complete attendance of all team members during the educational workshop or participation results presentations or to complete all the event requirements, the organizers retain the right to replace said team with a wait-listed replacement team.

As international sustainable development thought is trending and with the advent of economic and trade globalization, Corporate Sustainability (CS) and Corporate Social Responsibility (CSR) topics have emerged as key focal points, with many

international firms emphasizing the role played by CS/CSR in their industrial and economic activities, and viewing these as core strategies within their corporate operations.
